## **EDUCATION LOAN**

Applications for the above loan are invited. Members must have at least five years continuous membership to be eligible. If a member is applying on behalf of his/her child, he/she must be a member of the Koperasi for at least ten continuous years.

Application forms are available at the office and the closing date will be announced later.

The amount of loan advances is subject to the following limit:-

- For a 1 year course - RM 2,500.00
- For a 2 year course - RM 5,000.00
- For a 3 year course - RM 7,500.00
- For a 4 year course - RM 10,000.00
- For a 5 year course - RM 12,500.00
- For a 6 year course - RM 15,000.00

The Education Loan Fund Panel will select recipients each year for this loan and successful candidates will be notified in due course.
