- 3) Please cooperate to allow temperature check at the entrance of the venue. Hand sanitizer will be provided.
- 4) Only members who had been fully vaccinated (14 days after 2nd dose), with their vaccination status updated in "Mysejahtera" will be allowed entry.
- 5) Please wear your face mask at all times in the premises.
- 6) Upon completion of the above, you can proceed to the registration counters.
- 7) Kindly cooperate by following physical distancing as required under the SOP. To maintain 2 meters social distancing between members.
- 8) Nine registration counters will be set up:
 - a) COUNTER 1: Membership numbers beginning with letters A, B, D, E, F and G.
 - b) COUNTER 2: Membership numbers beginning with letter C.

c) COUNTER 3: Membership numbers beginning with letter H, I, J and K.

d) COUNTER 4: Membership numbers from L 0001 to L 0800.

e) COUNTER 5: Membership numbers from L 0801 and above and also membership

numbers beginning with letter M.

f) COUNTER 6: Membership numbers beginning with letters N and 0.


g) COUNTER 7: Membership numbers beginning with letters P, Q, R and S.

i) COUNTER 9: Membership numbers beginning with letters U, V, W, Y and Z.

- 11) In order to follow the SOP strictly, only 250 seats are available in the meeting hall.
- 12) Only members and working staff are strictly allowed to attend the AGM.
- 13) Any questions pertaining to the AGM must be submitted in writing to Coop office, one week before the scheduled date of the AGM.
